

## Terms and Conditions

### **“SONY STORE CELEBRATES SG60” PHOTOGRAPHY PHOTO CONTEST (“CONTEST”)**

Sony Electronics (Singapore) Pte. Ltd. (“Sony”) is responsible for organising “Sony Store Celebrates SG60” (“**Contest**”). By entering and participating in this Contest, participants agree to be bound by and to comply with the terms and conditions of the Contest (“**Terms and Conditions**”) and the decisions of Sony in relation to and in connection with this Contest. Sony reserves the right to cancel and/or amend the Contest and the Terms and Conditions at any time without prior notice. Any changes will be posted on the Site.

#### **Eligibility**

1. The Contest is open only to people of any nationality lawfully residing in Singapore who are 18 years or older as at the date of participation. For the avoidance of doubt, participation refers to submission of photos for the Contest. (“**Eligible Participant**”).
2. Notwithstanding the above definition of “Eligible Participant”, employees of Sony and its affiliates, advertising and promotion agencies of Sony together with their employees, Associated members of Sony and immediate family members and/or those living in the same household of each of the aforesaid persons are **not eligible** to participate in this Contest. “Associated members of Sony” in this context refers to Sony contracted coaches and their related staff.
3. Sony reserves the right to disqualify and/or exclude any entries or participants from the Contest, for any reason and for no reason, including without limitation, violation of any portion of these Terms and Conditions.
4. You warrant to indemnify Sony against any and all claims in relation to your participation of this Contest and breach of its Terms and Conditions contained herein. Sony’s rights are hereby expressly reserved.

#### **Contest Mechanics**

5. The Contest period is from 1 Jul 2025, 0000hrs (SGT) to 31 Aug 2025, 2359 hrs (SGT) (“**Contest Period**”).
6. **How to Enter Contest**

To enter the Contest, the Eligible Participant shall take and upload at least one (1) photo and up to a maximum of three (3) photos, reflective of the Contest Theme, and complies with the following criteria:

##### **Criteria:**

The Contest Theme is Citywalk & Architecture - Singapore Icon. More details on the Contest Theme can be found at the following link:

- a. The submitted photo(s) must be taken on or after 1 July 2025, in JPEG format and the file size shall not exceed 2MB.
- b. The submitted photo(s) must be saved in the RGB colour model.
- c. The submitted photo(s) must retain the original intact Exchangeable Image File (EXIF) format data.
- d. The submitted photo(s) must be captured using a Sony Interchangeable Lens Camera (ILC) and a Sony E-mount Lens (SEL).

- e. Post processing of the submitted photo(s) such as cropping, exposure, white balance, saturation adjustments are not prohibited. Digital removal of small objects that does not substantially change the submitted photo(s) are allowed.

## 7. Submission Requirements

- i. Photo submission must be submitted within the Contest Period. For the avoidance of doubt, it is not a requirement for the photo submitted to have been taken during the Contest Period.
- ii. The submitted photo must be shot with a Sony Interchangeable Lens Camera (ILC) and a Sony E-mount Lens (SEL).
- iii. Editing of photo entries is allowed, but excessive digital imaging or AI-generated treatments are prohibited.
- iv. Participants must retain the original photo for verification of original photo and metadata, including capture dates.
- v. The photo submitted shall not have been submitted for any other contest/competition and shall be an original photograph, free from any watermarks.
- vi. Upon request, the participant must be able to supply Sony and/or Sony Group with a high-resolution copy of the Submission(s) that is suitable for printing.
- vii. Upon request, the participant must be able to supply Sony and/or Sony Group an unretouched RAW or JPEG files of the Submission(s) for verification purpose.

## 8. Selection of Winners

- i. **Participation Reward:** Each participant who submits at least one photo will receive a **\$20 Sony Store voucher** (with a minimum spend of \$200), capped at **one voucher per participant**. Participants may submit up to **three (3) photographs**, but only **one voucher** will be issued per person.
- ii. All eligible entries will be judged by Sony based on the following Criteria ("Criteria"), on or before 1 July 2025. There will be One (1) Grand Prize Winner, One (2) Second (2<sup>nd</sup>) Prize Winner and One (1) Third (3<sup>rd</sup>) Place Winner.
- ii. The results of the Contest including but not limited to the names of the winner and the winning entry may be published on the Site and/or any social media channels of Sony and its affiliates.
- iii. We reserve the right in our sole discretion, to edit or delete any documents, information or other content appearing on the Site including disagreements, without any notice requirement or obligation to you.

21. 24. Any costumes, props or other materials used must be rented or borrowed with the permission of the owner, and all other relevant permissions must have been obtained.
25. Participant guarantees that any enhancement is made via use of legally acquired software.
26. You shall hold Sony and all of its officers, directors and employees free and harmless from any liability arising from claims or suits of third parties, including costs and expenses incidental thereto, in connection with the use of the Contest videos, photos and/or entries.
27. Where there are images or personal information of other individuals appearing in or associated with your entry, you confirm that the individuals have consented and agreed to you providing the images and personal information to Sony and that Sony may use the images and personal information for the purpose of this Contest.

40. Analysis of User Behaviour - We reserve the right to perform statistical analyses of user behaviour and characteristics in order to measure interest in and use of the various areas of the Site and to inform advertisers of such information as well as the number of users that have been exposed to or clicked on their advertising banners. We will provide only aggregated data from these analyses to third parties.
